The Ministry of Commerce and Consumer Protection (MCCP) is organising a logo competition for the Legal Metrology Services (LMS) on the occasion of the World Metrology Day to be celebrated on 20 May 2025.

**Objectives of the LMS**

The LMS is mandated to protect the public in their purchase of commodities by weight or measure and ensures that fair trade practices are carried out through accurate and reliable weights and measures. The LMS is also responsible for developing national standards for use in Legal Metrology in line with international standards and legislations. **LOGO DESIGN**

**Specifications & Conditions for participation**

- The logo must be original impactful and visually attractive.
- The logo must be in high resolution of at least 300 dpi.
- Pantone + CMYK colour and code are to be used.
- The logo should be in editable vector format (adobe illustrated or Encapsulated PostScript files).
- The selected logo shall be used as an official visual in different formats and sizes in publications, posters, flyers, website, official portals and others.
- The selected logo shall be used at both national and international level to represent the LMS.
- The name of the 'Legal Metrology Services' shall be included on the logo.

**ELIGIBILITY**

- The competition is open to all citizens of the Republic of Mauritius.

**ENTRIES**

- Each individual or group may submit a maximum of two entries.

**SELECTION CRITERIA**

- The logo shall be assessed in line with the objectives of the LMS.

**DEADLINES AND SUBMISSIONS**

- Deadline for submission: 15 May 2025  
Late submissions will not be accepted.
- Participants are required to submit the completed participation form and the logo design via email to [adminmccp@govmu.org](mailto:adminmccp@govmu.org) (mentioning 'Logo Competition' in the subject field) or at the Administration Section, Ministry of Commerce and Consumer Protection.
- For group submission, a contact person must be designated in the participation form, and his/ her contact details must be correctly written for future correspondences.

**JURY PANEL**

A jury panel will be constituted to review the contested entries and select the winner for the logo. The decision of the Jury shall be final and binding.

**Prize and Award Ceremony**

The winner of the logo competition will be awarded a cash price of Rs 25,000.

**OTHERS**

- Each entry shall be an original work and free from copyright. A signed statement to that effect shall have to be submitted by the participant (s) as per **Annex A**.
- The MCCP shall not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
- Once selected, the MCCP shall retain copyright of the logo.
- The jury reserves the right not to make any award following the competition.
