**THE CONSUMER PROTECTION  
(PRICE AND SUPPLIES CONTROL) ACT**

**Regulations made by the Minister under sections 3 and 35 of  
the Consumer Protection (Price and Supplies Control) Act**

1. These regulations may be cited as the Consumer Protection (Control of Price of Taxable and Non-taxable Goods) (Amendment No. 2) Regulations 2025.
2. In these regulations –  
     “principal regulations” means the Consumer Protection (Control of Price of Taxable and Non-taxable Goods) Regulations 1998.
3. The First Schedule to the principal regulations is amended, in Part I, by deleting the following item and its corresponding entries–

**Cement (paper bags of 25 kgs net each)**
