Consumer Protection (Control of Sale of Imported Live Animals for Home Slaughter) Regulations 2010

THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the Consumer Protection (Control of Sale of Imported Live Animals for Home Slaughter) Regulations 2010.
- 2. In these regulations –

"Division of Veterinary Services" means the Division of Veterinary Services of the Ministry responsible for the subject of agriculture;

"home slaughter" means the slaughter of a live animal on the occasion of the religious ceremony of –

- (a) Eid-UI-Adha; or
- (b) Akika;

"home slaughter authorisation" means an authorisation issued under regulation 4;

"live animal" means an imported animal listed in the First Schedule.

- 3. These regulations shall apply
 - (a) to the Island of Mauritius only;
 - (b) to animals imported for home slaughter only.

- 4. (1) Every person who intends to buy a live animal for home slaughter shall make an application in writing to the Division of Veterinary Services for a home slaughter authorisation.
 - (2) On receipt of an application under paragraph (1), the Division of Veterinary Services may direct the applicant to furnish such additional information as it may require.
 - (3) The Division of Veterinary Services may grant or refuse an application.
 - (4) Where the Division of Veterinary Services grants an application, it shall issue a home slaughter authorisation to the applicant, subject to such terms and conditions as it may determine.

- 5. (1) No person shall sell a live animal for home slaughter unless -
 - (a) the buyer holds a home slaughter authorisation;
 - (b) he weighs the live animal in presence of the buyer or the latter's representative; and
 - (c) the live animal, in the case of—
 - (i) cattle, is not less than 2 years old; and
 - (ii) goat or sheep, is not less than one year old.
 - (2) The seller shall weigh the live animal using a weighing instrument which -
 - (a) is approved by the Division of Veterinary Services; and
 - (b) is duly assized in accordance with the Legal Metrology Act.

(1) Each sale of a live animal for home slaughter shall be made by the seller and the buyer in a sale agreement.

- (2) The sale agreement referred to under paragraph (1) shall be made in duplicate and in the form set out in the Second Schedule.
- **6A.** (1) The retail selling price of imported live cattle shall, during the specified period, not exceed 174 rupees per kilogramme.
 - (2) In this regulation -

"specified period" means the period starting on 28 May 2024 to the day following 2 days after the religious ceremony of Eid-UI-Adha in the year 2024.

- **7.** Every person who contravenes any provision of these regulations shall commit an offence and shall, on conviction, be liable to a fine not exceeding 100,000 rupees and to imprisonment for a term not exceeding 3 years.
- 8. These regulations shall come into operation on 15 November 2010.
