

Government Notice No. 170 of 2020

**THE CONSUMER PROTECTION
(PRICE AND SUPPLIES CONTROL) ACT**

**Regulations made by the Minister under section 35 of
the Consumer Protection (Price and Supplies Control) Act**

1. These regulations may be cited as the Consumer Protection (Scrap Metal) (Amendment No. 2) Regulations 2020.
 2. In these regulations –
“principal regulations” means the Consumer Protection (Scrap Metal) Regulations 2019.
 3. Regulation 2 of the principal regulations is amended, in the definition of “scrap metal”, in paragraph (a), by inserting, after the words “third column of”, the words “Part A of”.
 4. Regulation 3 of the principal regulations is amended –
 - (a) in paragraph (1), by deleting the words “paragraph (2)” and replacing them by the words “paragraph (1A) or (2)”;
 - (b) by inserting, after paragraph (1), the following new paragraph –
 - (1A) Notwithstanding paragraph (1), no person shall export copper as described in Part B of the First Schedule.
 5. The First Schedule to the principal regulations is revoked and replaced by the First Schedule set out in the Schedule to these regulations.
 6. These regulations shall come into operation on 1 August 2020.
