# THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

# Regulations made by the Minister under section 35 of the Consumer Protection (Price and Supplies Control) Act

- 1. These regulations may be cited as the Consumer Protection (Control of Sale of Imported Live Animals for Home Slaughter) (Amendment) Regulations 2013.
- 2. In these regulations
  - "principal regulations" means the Consumer Protection (Control of Sale of Imported Live Animals for Home Slaughter) Regulations 2010.
- 3. Regulation 4 of the principal regulations is amended, in paragraph (2), by deleting the word "be".
- **4.** Regulation 5 of the principal regulations is amended, in paragraph (1)
  - (a) in subparagraph (a), by deleting the word "and";
  - (b) by adding the following new paragraph, the full stop at the end of subparagraph (b) being deleted and replaced by the words "; and"
    - (c) the live animal, in the case of
      - (i) cattle, is not less than 2 years old; and
      - (ii) goat or sheep, is not less than one year old.
- 5. The Second Schedule to the principal regulations is revoked and replaced by the Second Schedule set out in the Schedule to these regulations.
- 6. These regulations shall be deemed to have come into operation on 13 September 2013.
