

Government Notice No. 117 of 2025

**THE CONSUMER PROTECTION
(PRICE AND SUPPLIES CONTROL) ACT**

**Regulations made by the Minister under section 35 of the
Consumer Protection (Price and Supplies Control) Act**

1. These regulations may be cited as the Consumer Protection (Use of Liquefied Petroleum Gas in Small Cylinders) (Amendment No. 3) Regulations 2025.
2. In these regulations –
“principal regulations” means the Consumer Protection (Use of Liquefied Petroleum Gas in Small Cylinders) Regulations 2012.
3. The principal regulations are amended by inserting, after regulation 4, the following new regulations –
 - 4A. No person shall, at a time, sell, supply or deliver more than 4 units of Liquefied Petroleum Gas in small cylinders to any individual.
 - 4B. No person shall store or keep any Liquefied Petroleum Gas in small cylinders on any trade premises, other than a trade premises which he is authorised to use for the sale of Liquefied Petroleum Gas in small cylinders.
 - 4C. (1) Where a person is in breach of regulation 4A or 4B for a first time, an authorised officer of the Ministry shall issue that person with an Official Warning Notice in the form set out in the Schedule.

(2) Any person who, after having been issued with an Official Warning Notice pursuant to paragraph (1), contravenes regulation 4A or 4B shall commit an offence and shall –

- (a) on a first conviction, be liable to a fine of not less than 25,000 rupees;
- (b) on a second conviction, be liable to a fine of not less than 50,000 rupees;
- (c) on a third or any subsequent conviction, be liable to a fine of not less than 75,000 rupees.

4. The principal regulations are amended by adding the Schedule set out in the Schedule to these regulations.

5. These regulations shall come into operation on 26 November 2025.
