THE CONSUMER PROTECTION (PRICE AND SUPPLIES CONTROL) ACT

Regulations made by the Minister under sections 3 and 35 of the Consumer Protection (Price and Supplies Control) Act

- **1.** These regulations may be cited as the Consumer Protection (Consumer Goods) (Maximum Mark-up) (Amendment) Regulations 2016.
- **2.** In these regulations
 - "principal regulations" means the Consumer Protection (Consumer Goods) (Maximum Mark-up) Regulations 1998.
- **3.** The Second and Third Schedules to the principal regulations are revoked and replaced by the Second and Third Schedules set out in the First and Second Schedules, respectively, to these regulations.
- **4.** These regulations shall come into operation on 15 November 2016
